Just over 90% of customer IT environments we tested last year had significant IT vulnerabilities as well as data compliance risks.

3900 OF UK BUSINESSES HAD A CYBER SECURITY BREACH LAST YEAR - COSTING THEM APPROXIMATELY £8.8 BILLION. GALLAGHER 2020

Our tests revealed, organisations of all sizes being routinely exposed to unacceptable levels of risk from serious IT vulnerabilities and data management weaknesses. Common vulnerabilities included shadow IT and unsupported systems or missing security patches through to failing back-ups and anti-virus applications. Worst still, sensitive and personal data wasn't being secured correctly despite the risks and the existence of simple measures for securing such data.

7000 OF BREACHES ORGINATE FROM AN END POINT. 1 IN 4 SERVERS AREN'T PATCHED CORRECTLY IDC 2020 We consistently found serious IT and data risks irrespective of approach to IT Management. Risks associated with in-house IT were mostly linked to limited resource struggling to keep on top of IT management tasks or lacking specialist IT capabilties. In-house IT teams are increasingly looking to partners to fill these gaps. Data compliance issues involving the mis-handling of payment or personal information were rife despite assurances from IT that data was handled correctly.

Where IT was outsourced, we found instances of Managed Services
Providers simply not completing essential IT management tasks inline with their service agreements.


